Camping will be available on the grounds for a fee of \$40. Shower & toilet facilities will be on site. Please note there will be **limited powered** sites available. Powered camping and shower access is available approximately 10 minutes from the grounds at the Beverley Caravan Park (beverleycaravanpark.com to book). Beverley Caravan Park is dog friendly but they must be on lead at all times. Dogs aren't permitted in cabins. Alternatively, there are also caravan park options available approximately 20 minutes away in York.

Breakfast and lunch will be available for purchase on all days at the venue and a Welcome Barbecue be held there at \$15 per head on Saturday night. Another dinner will be held at the venue on Sunday at \$40 per head. For those of you looking for another option, dinner may also be purchased directly from the Freemasons Hotel in Beverley (unfortunately not available on Monday or Tuesday). Bon appétit ©


